

Terms and Conditions of Sale

- INTERPRETATION
- In these conditions the following words have the following meanings "the **BUYER**": the person(s), firm or company who purchases the Goods 1.1 from the Company. "the COMPANY": Laser Process Ltd.

"COMPANY PREMISES": Upper Keys, Keys Park, Cannock, Staffordshire,

Nothing in this Condition will exclude or limit the company's liability for fraudulent misrepresentation. Each order for Goods by the Buyer from the Company shall be deemed to be an offer by the Buyer to purchase Goods subject to these Conditions. - specification are complete and accurate. Any quotation is given on the basis that no contract will come into 2.6 existence until the Company has accepted a purchase order from the Buyer. Any quotation is valid for a period of 30 days only from its date,
- provided that the Company has not previously withdrawn it. If the Goods are to be manufactured or any process is to be applied to the 2.7 Goods by the Company in accordance of any process is to be applied by the Buyer, the Buyer shall indemnify the Company against all loss whether direct or indirect, damages, costs and expenses awarded against or incurred by the Company in connection with, or paid, or agreed to be paid by the Company in settlement of any claim for infringement of any patent, copyright, design, trade mark or other industrial or intellectual property rights of any other person which results from the Company's use of the
- Buyers specification. No order which has been accepted by the Company may be cancelled by 2.8 the Buyer except with the agreement, in writing, of the Company and on terms that the Buyer shall indemnify the Company, in full, against all loss (including loss of profit), costs (including the cost of all labour and materials used), damages, charges and expenses incurred by the Company as a result of the cancellation.
- DESCRIPTION
- 31 The description of the Goods and any specification for them shall be as set out in the Company's quotation (if accepted by the Buyer) or the Buyer's order (if accepted by the Company) shall be as set out in the Company's
- quotation. All other descriptive matter, specifications and advertising issued by the 3.2 Company and any descriptions or illustrations contained in the Company's catalogues, brochures or web pages are issued or published for the sole purpose of giving an approximate idea of the Goods described in them. They will not form part of this Contract. DELIVERY
- Delivery of Goods shall be made by the Buyer collecting the Goods at the Company's Premises after the Company has notified the Buyer that the Goods are ready for collection, or, if some other place for delivery is agreed by the Company, by the Company delivering the Goods to the Delivery 4.1
- The Buyer will take delivery of the Goods within 7 days of the Company 4.2 giving it notice that the Goods are ready for delivery. If the Company has agreed to deliver the Goods to the Delivery Point then

- the Buyer will be obliged to pay the Goods to the Delivery Charge unless explicitly agreed otherwise by the Company in writing. Any dates specified by the Company for delivery of the Goods are intended to be an estimate and time for delivery shall not be made of the essence by notice. If no dates are so specified, delivery will be within a reasonable 4.4 time. Subject to the other provisions of these Conditions the Company will not be
- 4.5 liable for any direct, indirect or consequential loss (all three of which terms include, without limitation, loss of profits, loss of business, depletion of goodwill and like loss), costs, damages, charges or expenses caused directly or indirectly by any delay in the delivery of the Goods (even if
- caused by the Company's negligence, nor will any delay entitle the Buyer to terminate or rescind the Contract unless such delay exceeds 30 days. If for any reason the Buyer will not accept delivery of any of the Goods when they are ready for delivery, or the Company is unable to deliver the Goods on time because the Buyer has not provided adequate instructions, documents including but without limitation engineering drawings, licenses 4.6 or authorizations:

- risk in the goods will pass to the Buyer (including for
- loss or damage caused by the Company's negligence) the Goods will be deemed to have been delivered and b) c) the Company may store the Goods until delivery whereupon the Buyer will be liable for all related costs

- The Buyer will provide at its expense at the Delivery Point adequate and 4.7 appropriate equipment and manual labour for offloading the Goods

- 5.1 The quantity of any consignment of Goods as recorded by the Company upon dispatch from the Company's place of business shall be conclusive evidence of the quantity received by the Buyer on delivery unless the Buyer

The Company shall not be liable for any non-delivery of Goods (even if caused by the Company's negligence) unless written notice is given to the Company within 7 days of the date when the Goods would, in the ordinary course of events, have been received. 5.2
- Any liability of the Company for non-delivery of the Goods shall be limited to replacing the Goods within a reasonable time or issuing a credit note at 5.3 the pro rata Contract rate against any invoice raised for such Goods. RISK / TITLE

- The Goods are at the risk of the Buyer from the time of delivery. Ownership of the Goods shall not pass to the Buyer until the Company has 6.1 6.2 received, in full (in cash or cleared funds) all sums due to it in respect of: a)

- If the Buyer fails to pay the Company any sum due pursuant to the Contract the Buyer will be liable to pay interest to the Company on such 8.6 sum from the due date for payment at the annual rate of 3% above the base lending rate from time to time of Barclays Bank PLC, accruing on a daily basis until payment is made, whether before or after judgment. The Company reserves the right to claim interest under the Late Payment of Commercial Debts (Interest) Act 1998.

The Company reserves the right to defer the date of delivery or to cancel the Contract or reduce the volume of the Goods ordered by the Buyer (without liability to the Buyer) if it is prevented from or delayed in the carrying on of its business due to circumstances beyond the reasonable control of the Company including, without limitation, acs of God, governmental actions, war or national emergency, acts of terrorism, protests, riot, civil commotion, fire, explosion, flood, epidemic, lock-outs, strikes or other labour disputes (whether or not relating to either party's workforce), or restraints or delays affecting carriers or inability or delay in obtaining supplies of adequate or suitable materials Provided that, if the event in question continues for a continuous period in excess of 90 days, the Buyer shall be entitled to give notice in writing to the Company to terminate the Contract.
