For some developments the presence of bats can be complicated – mainly because of the timing when surveys can be undertaken to determine the species, the type of roost and its significance.

However, our team of fully qualified and licensed bat ecologists are here to help and will work with you to ensure that your project can still meet deadlines and get through planning.

CEC's bat team undertake bat and barn owl assessments, emergence surveys, remote detector surveys, European Protected Species Licensing, hibernation surveys, watching briefs and

monitoring visits.

It's important to use a licensed bat ecologist. An ecologist who isn't licensed cannot legally undertake a survey if there are bats present! This is a costly and time consuming mistake which you can avoid by employing a licensed bat ecologist in the first instance.

Truro Park & Ride

CEC was commissioned to undertake ecological surveys, including Phase 1 habitat and Protected Species, for Langarth Park & Ride, Truro, and our landscape architects led the conceptual and detail design in liaison with the Highway Design Group of Cornwall Council.

The scheme design and construction followed a tight timescale – planning permission was achieved less than a year from starting the conceptual design.

Sustainability is at the heart of the scheme. The design respects and reflects the quality of the Cornish landscape through choice of materials and planting and great care has been taken to retain and protect existing wildlife wherever possible including trees and Cornish hedges as well as bats and badgers.

The scheme produced an overall biodiversity gain and - as the tree and buffer planting matures, the site will take on the feel of a parkland. In the long-term the foundation will have been laid for an urban park with mature trees and meadow areas in the transitional area between the urban edge and the open landscape.

This development demonstrates the benefits of our ecology and landscape teams working together on a project.





Eco Communities

Located approximately 2.25km from St Austell town centre, proposals were for around 2000 sustainable dwellings, realignment of the A390, a transport interchange, a network of footpaths, cycleways, bridlepaths, town centre, community hubs, primary school, sports pitches, allotments, formal and informal public open space, large scale water bodies and habitat restoration / creation.

The CEC ecology team completed bird surveys, bat surveys, invertebrate surveys, nightjar surveys and Code for Sustainable Homes assessments.

CEC's expertise in Landscape and Visual Impact Assessment enabled a comprehensive and realistic assessment of the likely effects of the proposals on a complicated post-industrial site in a semirural location. With deep, steeply terraced former

clay pits, a towering mica dam and conical tips, we adapted the standard LVIA methodology to ensure that the site's value as an open space and the distinct character of the area was carefully considered.

The project demonstrates CEC's capabilities to work with a difficult and complicated site to a tight deadline, and our ability to tailor our approach to meet the site and client's needs.

Tehidy Country Park

Tehidy Country Park, situated approximately 0.5 km to the north of Camborne, Pool and Redruth, features over 9 miles (14.5km) of paths and 250 acres of woods and lakes, together with a café and a picnic area.

Managed by Cornwall Council since 1983, Tehidy was formerly the estate of the Bassets, one of the most powerful families in Cornwall with extensive landholdings and mineral rights in the western part of the county. Tehidy House was once one of the finest in Cornwall and has now been converted into residential flats.

CEC worked with Cornwall Council to prepare a management plan for Tehidy Park to restore and enhance the parkland as a heritage, ecological and recreational resource in the future.

Together with Historic Environment Projects we undertook a detailed investigation of old records, maps, plans and photographs to piece together the story of the Park and how it developed over time – the views, footpaths, statues, boundaries, avenues and planting etc. A tree survey and ecological survey were also carried out to ensure that any proposals will not damage Tehidy's nature conservation or landscape importance.

CEC produced a detailed management plan for the site using the expertise of both the ecology and landscape architecture team.
