





NORTH AMERICA AND CANADA CERTIFICATION


An NRTL is an independent third-party organisation recognised by the Occupational Safety & Health Administration (OSHA) to provide evaluation, testing and certification of products.

Recent changes to the rules means that the NRTL can accept the ILAC / UKAS accredited tests reports issued by Cranage, this means that we are able to evaluate your products at our laboratories and provide you with any assistance needed throughout the product testing stages. This can greatly reduce the assessment time, meaning the North America and Canada certification can be obtained in the shortest time possible.

The key benefits Cranage can now offer:

- Test and evaluate products to North American standards either at Cranage, or on your premises
- Perform the mandatory factory inspections on certified products bearing the NRTL mark
- Evaluate "one-off' products which are handled under ISO Type 1 certification and do not require factory surveillance or inspection

Existing product approval arrangements can be easily transferred - subject to passing a technical review.




CERTIFICATION BODY SCHEME – CB CERTIFICATION

We can offer testing for the Certification Body Scheme (CB) for Medical devices at your premises. This IECEE CB Scheme is a multilateral agreement between participating countries and their resident certification organisation, meaning any product with CB certification will be accepted by participating organisations around the world.

Cranage Veritas is in a unique position to have a registered Engineer listed with a National Certification Body (NCB) under the CB scheme. We have the authority to perform CB testing at the manufacturers location and provide CB reports and certification through the NCB for Medical Devices , IT and Measurement Equipment

The registered Engineer is known as a Local Technical Representative (LTR). The LTR operates under the responsibility of National Certification Bodies, and the LTR performs the testing and/or supervisory activities locally at a Customers Testing Facilities.
