Spartan Mullion Audio/Video Panels

The Spartan Mullion Audio/Video Miniature Entrance Panel has been specifically designed for flush mounting on narrow wooden and metal door frames. It is available in standard format with audio speaker and microphone, pin-hole camera (mono or colour), optional message panel (integral or separate) and one functional call button. Additional call buttons can be fitted either by omitting the camera and/or message panel or by lengthening the panel.

Method of Operation

This entrance panel is used in conjunction with either the standard Elvox 8875 or Petrarca audio handset or the Giotto combined audio/video handset and monitor with a 4" mono or colour screen. In panels where an integral message window is fitted, the message 'CALL' will be illuminated when the call button is pressed. When the internal handset is lifted, the message will change to 'TALK' and on door lock activation, the 'ENTER' is displayed. The main purpose of the message window is to help those visitors who may have impaired hearing.

Adjustments

Microphone volume on panel. Speaker volume on Elvox power supply. Camera fixed.

Dimensions

The dimensions of the standard panel for mounting in wooden or metal door frames shown (A) is 249 x 40mm. Whilst the length may vary according to the particular configuration required, the width remains at 40mm.

A slightly larger unit with backbox is also available for mounting in brickwork and measures 277 x 56mm.
